TERMS & CONDITION OF CONTRACT

- The sealed quotation will be received in the Tender Box of Office of the Supdt. of Horti. & Soil Conservation, Kumarghat Horti. Sub-Division, Unakoti Tripura, on 02/07/2019 from 11:00 a.m to 3:00 p.m & will be opened in the office of the undersigned on 02/07/2019, at 4:00 pm, if possible. The quotationer or their authorized representative may present at the time of opening of the quotation.
- Rate should be quoted per unit both figures & words for each supply items inclusive expenses for weighting, loading, unloading-stacking & head carrying if required. There should not be over writing, no deviation of the terms & conditions contained in this quotation notice will be terminated.

3. Transportation of materials up to the destination points of delivery should be completed within 24 hours from the time of loading adequate vehicle for transportation should be placed at loading points within 24 hours on receipt of such intimation. In case of delay in the placement of vehicle, if any damage occurred, the cost of materials will have to be borne by the contractor.
1. No transport shortage will be allowed under any circumstances.
5. The value of the quantity found short at delivery point including container, if any will be recovered from the transport contract at rate which will be fixed by the Govt. of Tripura and such quantities will be treated as not carried, carrying cost of the said quantity cannot be claimed.
6. All precautionary measures should be taken at the cost of the contractor, so that the Agri. Inputs may not get water damaged in any way during loading, transit and unloading.
7. No, materials should be transported along with the Agri. Inputs in the same vehicle, which may cause damages of Agri. Inputs and other materials of the Deptt.
8. Each tender should accompany Earnest money Rs.10,000/- (Rupees Ten Thousand) only in the shape of "Deposit at call" from any Nationalized/ Govt. undertaking Bank of India in favour of the undersigned.
9. Up to date PTC, GST Registration, ITC and Nationality certificate should also be enclosed with the tender, failing which the tender will not be entertained.
10. The Department vehicles will generally do the carrying of Agri. Inputs. The carrying contractor will be engaged as and when required when the Deptt. vehicles are not available or cannot cover the volume of transportation of Agri. inputs.
11. The earnest money of the successful tenders shall be returned only after acceptance of rate only. The earnest money of the successful tenders shall be treated as a part of security money, if the written request is received from the tenderer.
12. The rate will remain valid up to 1 (one) year if approved by the Govt. & be extended or curtailed if necessary.
13. Use of hooks at the time of loading & unloading or transport period is strictly prohibited.
14. In the event of failure to transport from the prescribed place destination points within the stipulated period, the Govt. shall have the right to get the work done through any other arrangement partly or wholly and extra expenditure including payment of damage if any involved such event shall have to be made by the contractor.


