Applications are invited in the prescribed form from bonafide citizens of India for selection of candidates for recruitment to **Tripura Judicial Service, Grade-III (Group-A, Gazetted)** under the **Law Department, Govt. of Tripura** in the scale of pay Rs. 27,700-44,770/-, higher initial pay may be recommended by the Commission for specially qualified and experienced candidates.

As per Rule 8 of the Tripura Judicial Service Rules, 2003, the posts reserved for ST & SC candidates will be filled by UR candidates, if suitable reserved category candidates are not found.

The Educational Qualification and Age are mentioned below:-

Educational Qualification Essential:- Degree in Law granted by a recognized University established by Law in India.

General Instructions:-

Scheme of the Examination:- The Examination will comprise of three successive stages viz.(i) Preliminary Examination (Multiple Choice Type Test), (ii) Main Examination (Conventional Type Test) & (iii) Viva Voce, details as mentioned below:

(i) Preliminary Examination (100 marks):

The Preliminary Examination will consist of one paper containing Multiple Choice Type Questions on General Ability Test with two hour duration. The Preliminary Examination will be a Screening Test for selection of candidates for admission to the Main Examination. A limited no. of candidates, Maximum 10(ten) times of total posts (in category wise) will be selected merit wise on the basis of the result of the Preliminary Examination, subject to securing minimum qualifying marks (60% for UR candidates and 50% for reserved category candidates). The marks obtained by the candidates in the preliminary Examination will not be taken into account for the purpose of determining the final merits list.

(ii) Main Examination(400 marks):

The Main Examination will consist of four papers of Conventional type Questions namely: English, General Knowledge, Law Paper-I and Law Paper-II. Full marks for each paper will be 100 and time allotted will be 3 hours for each paper. In no case a candidate will be called for viva voce unless he / she appears in all the papers of the Examination. **Answer to the questions of Main Examination should be answered in English only.**

A limited no. of candidates, maximum 3(there) times of total posts (in category wise) will be selected merit wise on the basis of the result of the Main Examination, subject to securing sixty percent (60%) or more or corresponding grade in the written examination for UR category and fifty percent (50%) or more or corresponding grade for scheduled Caste/Scheduled Tribe category in the Written Examination.

(iii) Viva Voce (100 marks).

Age:- up to 35 years as on 29.01.2019. Age is relaxable by 3(three) years in case of SC/ST candidates.

The last date of receiving application is 29.01.2019. The application(s) received after the closing date will not be entertained.

The applications along with necessary documents (regarding Qualification from Madhyamik onwards, Experience, Permanent Residence Certificate/Citizenship, Age proof Certificates should be addressed to the Secretary, TPSC, Agartala, West Tripura and submitted in the Tripura Public Service Commission Secretariat during working hours.


Online Application Portal will be available on Commission's website from 27.12.2018 to 29.01.2019 Before applying for the post, an applicant shall register his/her bio- data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz www.tpsc.gov.in. Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply for the post using the OTPR User ID through Commission's website.

The Candidates may also fill & submit application form in Receive section TPSC (purchasing from any branch of Tripura Gramin Bank) or send it by post which should be addressed to the Secretary, TPSC, Agartala, West Tripura, PIN-799001 during working hours.
